- 2. Town Hall with Winnipeg Police Service and Shawn Nason
- Tomi, Eric, Steve attended and found it informative and helpful
- Presentations about various serious issues in the city, all by police officers
 - Drugs, guns and gangs, inspectors, etc
 - What to look for re: gangs, tagging, signs in kids, code words / terminology
 - Drug squad focused on methamphetamine
- There are few police patrols in our area; we're not on their radar
 - We need to report every crime and concern so that they can monitor crime levels
 - We need to know the difference between urgent vs not urgent matters and how to report them
 - Tomi will post on FB regarding reporting; Martin will post on our website
 - Adriana will prepare information for them to post
- COPP: Citizens on Patrol Program
 - o Provincial program made up of local citizens' patrols
 - Tomi has a contact and we can invite her to come to an executive meeting if we decide to go through with the program
 - The program includes getting speed signs (the kind that show how fast you're going)
 - We will consider this program if the current situation deteriorates; we will check crime statistics
- Neighbourhood Watch
 - There's already a Neighbourhood Watch in one part of our neighbourhood: residents have been distributing decals on Morning Glory and Linmar

- Steve will invite the Neighbourhood Watch captains to a future executive meeting; we are in agreement that we need this program in the community
- Eric will investigate getting more "All Valuables Removed" signs for cars and "Slow Down, Children Playing" signs.
 - These can be passed out to all residents during canvassing or at the BBW

 - o To be considered once the road work has been completed
