- 1. Minutes from the last meeting were approved
- 2. Meeting with Ed Rust
 - o Information on the LakePark Estates (condos backing on to the lake)
 - Ed is vice-president of the condos association LakePark Estates (backing on to the lake)
 - Ed's number: 204-430-9026
 - John McIntyre is president
 - o 5 members
 - Condos own a part of the park area (almost up to the path)
 - \circ $\;$ Joint efforts with the city to look after the grass area, maintenance of the park, etc.
 - Class-action suit against the roofing company; won and the roofs have been replaced
 - o Idea is to beautify/enhance the boulevards with shrubbery
 - Someone from parks and rec came and took a look and provided a drawing
 - The boulevards are the responsibility of the City; not in the budget this year (summer 2017)
 - Something to bring up during election year
 - Community support (vs. a contentious project) will increase our chances of getting a project passed
 - Stone structure ('Lagimodière Park') is eroding and needs to be supported; call the city to inspect and repair

 - Placement: north entrance, past the condos
 - Timeline: TBD, waiting on City approval
